Application Deadline

Applications for admission are accepted beginning October 1, 2025, for the 2025-2026 Academic Year. Thirty-five students typically enter the program each year, including some who qualify for the Standard Curriculum and others who are eligible for the Two- Plus Curriculum. Among those with completed applications, the core faculty will determine those who will be advanced to the next phase in the process, that is, a group-based interview. Interviews will be by invitation only and will occur online. After interviews, applicants are admitted on a rolling basis within 4-6 weeks of an interview.

Application Required Materials

The following items are required to complete an application to the Master of Arts in Counseling Program. All materials including this application will be uploaded into CollegeNet. Applications will not be reviewed until all required materials are received.

- 1. Complete this **Program Specific Application** Note Curriculum Track: **Standard or Two Plus**
- Complete TGS on-line application through <u>CollegeNet</u> accessed through TGS Website, providing information requested of all applicants to The Graduate School as well as programspecific information
- 3. Curriculum vitae or professional resume accounting for all time periods from the start of your undergraduate studies to the present, beginning with your most recent activities. Describe those academic and clinical experiences that you listed in the Curriculum Selection chart above. Include schooling, part-time, summer, and full-time work experience, travel, job search, etc. Specify dates, employer/school, job title, the average number of hours per week, and primary responsibilities. Pay particular attention to describing activities in the field of mental health.
- 4. Upload scanned versions of **unofficial transcripts**. We require a transcript for every institution attended since secondary school and a transcript must be submitted for every institution listed in CollegeNet.
- 5. Request **letters of recommendation** through CollegeNet. We require two letters of recommendation addressing the applicant's ability to do scholarly work. Recommendations should be from individuals with whom you have had an academic or professional relationship. Recommenders must complete and upload by the application deadline (December 2, 2025).

- 6. **TGS Personal Statement** (125-250 word maximum)
- 7. MAC Program Academic Statement (1,000 word maximum)

The Master of Arts in Counseling | Clinical Mental Health Counseling Program leads to a Master of Arts in Counseling. The designed outcome is to lead to eligibility to become a Licensed Professional Counselor within Illinois. States typically have additional post license requirements to become eligible for an independent practice license, including additional hours under supervision and testing. In Illinois the independent practice license is Licensed Clinical Professional Counselor (LCPC); other states may have a different license name.

The Program is accredited by The Council for Accreditation of Counseling and Related Educational Programs (CACREP). Some states may require a different specialized accreditor or may have additional requirements for licensure.
